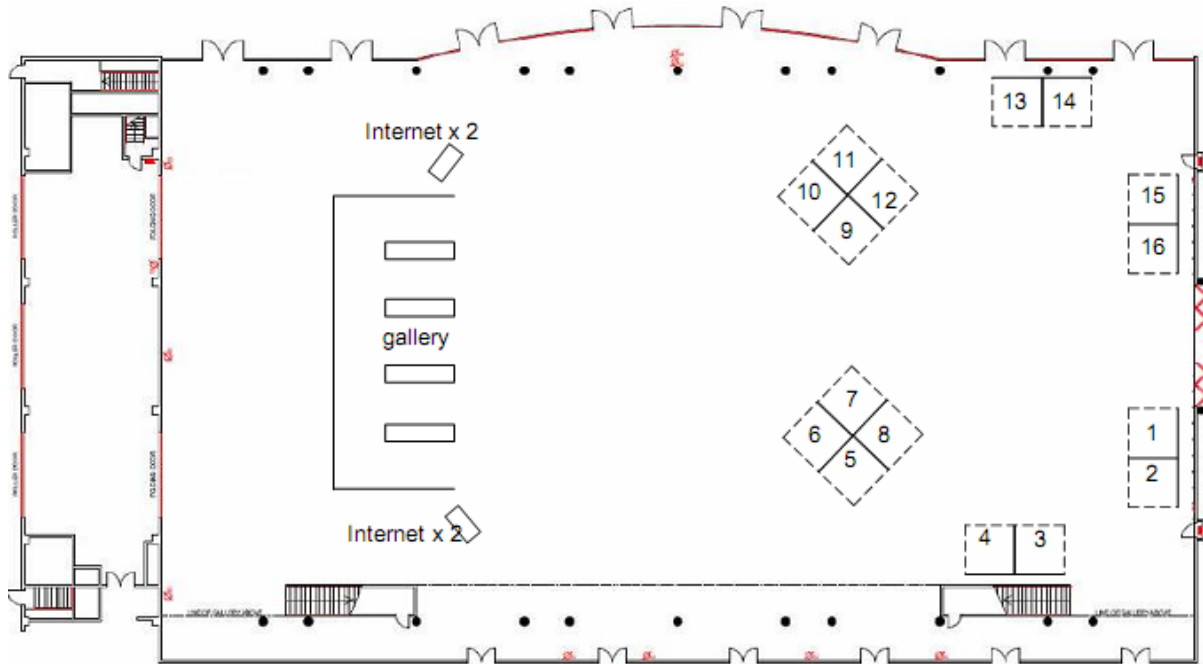

- Balance due 30 July 2010. If the balance of payment is not received by the due date, the allocated package/s will be cancelled.
- If you cancel a sponsorship or exhibition booths/s, unless that particular area of sponsorship or exhibition space is resold, the conference organising committee reserves the right to retain monies received. If the space or sponsorship item is resold a penalty payment of up to 50% will apply. If the balance of payment is not received by the due date, the allocated sponsorship or exhibition booth/s will be cancelled. Deposits are non-refundable. After Friday 24 September no refunds will be issued due to commitments made to suppliers.
